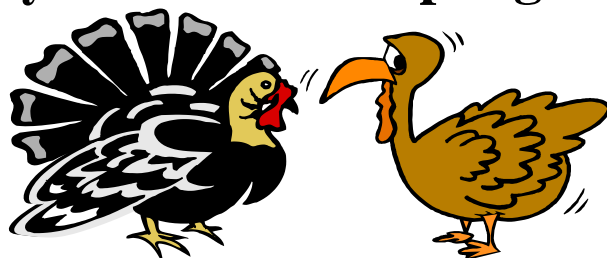

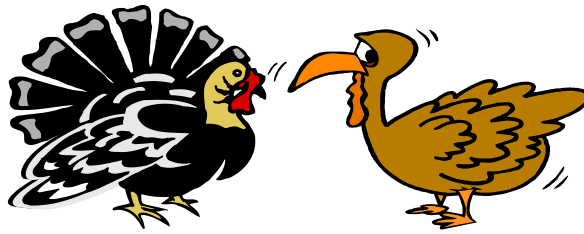

Driving Directions: **From the North and South:**

I-5 Roseburg exit 124 ("To Hwy 138 Diamond Lake / Glide"). Follow signs through Roseburg to Diamond Lake / Glide (Hwy 138 East). Drive approximately 5 miles on Diamond Lake Blvd. Turn right at the **Dixonville** sign. This takes you to Buckhorn Rd. Proceed east (left) on Buckhorn Rd. You'll see the Dixonville Store on the left. Go 3.8 miles past the Dixonville Store. Magnolia Farm is on the right. Continue on 100 yards; go through gate on the right.

Parking will be at top barn. Participants will be notified a week prior to trial of any parking changes.
