Auditors: \$50.00 a day (lunches included if you sign up at least one week in advance)

Start time: Due to the shortness of the days, the clinic has been limited to 13 participants and we need to start promptly at 8am and the sun will set on us by about 4:30.

Please arrive on time and of course in the NW it goes without saying to be prepared for bad weather! We hope for the best, but will have tents up and the barn is available for coffee and a hot lunch.

Lunches – depending on the weather it will be sandwiches, salads, soup, etc. Please bring whatever you want to drink.
